Executive Director – NIP Group - E. Miller

- Fast Track Mr. Miller advised that, as has been the custom, the year end Fast Track report is being reconciled with the 2013 year end actuarial report and will be provided once the analysis is complete.
- o Investment Report Investment returns are lower in 2013 vs. 2012 because no trades were made to realize additional gains. Fund assets remained primarily invested in the same instruments as the previous year.
- o Financial Disclosure Statements the Commissioners were asked to provide Ms. Delgado with copies of their Financial Disclosure Statements.
- o PEJIF the PEJIF launched successfully effective 1/1/14 with four members Passaic, Plainfield, Perth Amboy and West New York.

o 2014 Coverage Improvements – Mr. Hall reported on the coverage improvements negotiated with the Fund's excess carriers.

Wellness, Safety and EPL Training – A. Ven Graitis – Wellness – The GSMJIF Wellness Committee will be rolling out a Biggest Loser Challenge to start in March and to run approximately 2-3 months. Employee incentives will be provided, weekly bulletins and progress updates distributed, with percent of body weight being evaluated.

EPL training should be scheduled as needed with PMA and/or the EANJ. In2vate on line training will also be rolled out to supplement training.

The Safety First pilot program is ongoing and meetings are being scheduled. Updates will be provided at future meetings.

Claims Update – *Robert Persico* – Bob presented an update on the IVOS Claim system implementation. The go live date is February 3rd and staff training will take place during the last week in January. The old AS-400 system will continue in operation and the members can still review claim notes by way of the 400 system.

On –line claim reporting will continue as is and in about 30 days training for members who want to review notes from IVOS will take place.

Treasurer's Report – *Patrick DeBlasio* - Mr. DeBlasio reviewed the monthly treasurer's report and cash management account and advised that the Fund has met all outstanding obligations and its financial position is secure.

Commr. Ruggiero requested Treasury reports for years 2012 and 2013 to make comparisons on the movement of surpluses and deficits in all Fund years.






