- o **Fast Track** The Fund continues to maintain an overall surplus position, with a slight increase for May vs. April. The re-opening of some workers' compensation claims in 2006 has led to an increase in the 2006 deficit since 12/31/13, however, years 2009-2013 show slight improvements to their overall surpluses.
- o **Bylaws Review-** After careful review of our current Bylaws, it appears that no substantive changes are necessary. Unless members have any comments or suggestions it is recommended that the bylaws not be amended at this time.
- Fund Counsel Opinion on APD Direct Pay Program It was agreed that those members with local
 ordinances requiring a bidding process for this service should opt out of the program. The Fund
 Administrator will identify shops in proximity to those members who will participate and obtain service
 and pricing commitments.
- o **NJDOBI Audit** –The audit report is still in draft format, but we expect finalization shortly. We will be teleconferencing with the Department's actuary to discuss loss reserves at 12/31/12.
- o **Risk Manager Webinar (J. Hall)** Jonathan indicated that the 2015 renewal process is underway. Please contact him if you have any questions regarding such.

<u>Wellness, Safety and EPL Training – A. Ven Graitis, VP of Risk Control – Wellness, EPL and Safety & Wendy Wiebalk Litigation Manager</u>

- o **Safety Initiative Updates** *A. Ven Gratis* SERVE is continuing strong with several hundred seats assigned.
- o **In2vate** A. Ven Graitis Will receive more focus in the upcoming months to promote auto, police, fire and EMT professional, employment practices, and other training modules.
- o **The Biggest Loser Challenge -** *A. Ven Graitis* -Continues with the 35 teams competing with approximately two weeks to go. Team Ham Head is from Union and has a total of 6.55% body weight loss. Feather Weights and SouperFatPats are both from Parsippany with 6.43% and 5.78% body weight loss respectively. Teams from Maplewood and Lawrence are not far behind the leaders.
- o **Safety First "Decal" Program -** *A. Ven Graitis* -Is proceeding smoothly. West Orange and Parsippany both have the decals deployed on vehicles. We are still waiting for vehicle lists from several members that Risk Control will be following up with over the next week or two.
- Stewardship Reports A. Ven Graitis Stewardship reports will be distributed electronically this week. Claim trends continue to be positive, especially in Workers' Compensation frequency and also lost



time claim rates. Additional focus will be placed on addressing automobile and liability hazards where claims rates are down from 2012 but slightly up from 2011.

 Wendy spoke about employees' rights in the workplace in regard to various Internet and employer/employee communication issues.

Claims Update - Robert Persico Vice President Claims

o Workers Compensation Voluntary Tenders – R. Persico – The WC Claim Team will increase the use of voluntary tenders which will compensate those employees quicker with severe injuries and produce saving for the GSMJIF by paying a lesser fee to the employees attorney.

Presentation – **Certificate of Insurance Management** – **Martin Mick, CEP, Risk Toolbox** – Mr. Mick introduced the Risk Toolbox software which updates and tracts Certificate of Insurance requests.

Treasurer's Report – Patrick DeBlasio

Mr. DeBlasio reviewed the monthly treasurer's report and cash management account and advised that the Fund has met all outstanding obligations and its financial position is secure.
