# **Executive Director – NIP Group – J. Hall**

- Fast Track Mr. Hall indicated that there hasn't been much change compared to the past reports (July & August.) Mr. Hall discussed the ProForma \$4.7 million all-years surplus once the Supplemental Assessment is booked.
- **ProForma 2016 Budget** Mr. Hall presented the ProForma 2016 Budget and the drivers (loss fund rates, excess rates, expenses, and exposures). There were no questions from the membership.
- **Member Renewals** Mr. Hall indicated that all renewals have been received with the exception of 2 members. He asked them to please have the outstanding renewals to be submitted via their risk managers.
- **Prospects** Mr. Hall listed the prospects who have submitted to the GSMJIF for 2016 membership.

# Wellness, Safety and EPL Training – A. Ven Graitis – Wellness

• Police Training: Brit Seminar Recap, Connell Consulting, TACT - Brit Insurance hosted their inaugural regional risk management seminar titled, "Liability Prevention and Risk Management in Law Enforcement: Tips for Improvement in Ten Areas that Make a Real Difference," on Thursday, October 15, 2015, 9:00 a.m. to 2:00 p.m. at the Senior Citizens Center in Union. Approximately 70 people attended. The speakers were Randy Means, founding partner of the Charlotte-based Thomas & Means Law Firm, specializes entirely in police operations and administration and assists a broad national clientele, and Sgt. Jim Craige of the Alexandria (VA) Police Department where he manages its Tactical Computer System. Topics included Recruiting and Hiring the Right People to be Police Officers, Proper Use of Policy and Directives Manuals, Enhanced but Low-Cost Training and Testing Systems, Managing Use of Force and High Speed Driving, and Use of Body Worn Cameras and Other Recording Devices. has also partnered with Connell Consulting to provide police supervisory training with additional classes being provided in November. TACT training seminars are being scheduled for this year into early 2016.
