EXECUTIVE DIRECTOR'S REPORT – NIP Group – J. Hall

• **2016 Year-End Actuarial Report Status** – Mr. Hall reported that the first draft of the year-end actuarial study has been received and is being reviewed. As soon as the study is finalized, the Fast Track Reports will be updated and distributed to all Commissioners.

• **Presentation on 2017 Excess Insurance Highlights** – Brian Erlandsen & Frank Kelly (BGIA) – Brian Erlandsen and Frank Kelly of BGIA discussed highlights for the members Excess Insurance. The presentation has been distributed to members via email.

SAFETY DIRECTOR – PMA Group (K. Child) and NIP Group (A. Ven Graitis)

- Hearing Conservation Dr. Phil Passes of ESI Medical presented on Hearing Loss Prevention, common hazards in the municipal workplace, and aspects of a good hearing loss prevention programs including noise exposure monitoring, engineering and administrative controls, hearing protective devices, education, record keeping, and audiometric testing. ESI Medical is available to assist GSMJIF municipalities in all aspects of their hearing conservation programs and will meet on member site locations.
- Safety Meeting Recap The following items were addressed at the Safety Fund Meeting:
 - Wellness Committee update and current ideas being discussed, including a Walk to Win Competition and Fit for the Summer challenge.
 - Code Blue Legislation. Risk Control will advise members once the bill is signed into law but recent legislation looks to provide liability protection for volunteer organizations and political subdivisions acting accordingly to the law, requires government support be provided to volunteer organizations requesting assistance, and requires every county and municipality (with at least 10 homeless people) to have a plan in place to take care of the homeless during cold winter months.
 - Cyber Security: A bulletin with information from the US Government will be shared on Cyber Security and Ransomware. Many municipalities in New Jersey have been attacked and members should take precautions to prevent a breach including use of trained IT professionals, backups, risk analysis, staff training, vulnerability patching, application whitelisting, incident response, business continuity, and penetration testing.
 - Class III Officers: Chief Dennis Connell and risk control personnel are available to meet with member police chiefs entertaining the use of class III officers to ensure proper policies and procedures are in place and the appropriate training is provided to officers prior to assignment. Risk Control will reach out to members advising that they are proceeding with class III officers.
 - Right to Know Update addressed and assistance is available.

- Best Practices Managing Traumatic Events Seminar is scheduled for March 23, 2017, at the Union Township Senior Center from 10:00AM to 2:00PM. All member municipality representatives are invited.
- "When Words Fail" Police training in verbal de-escalation and safe take downs is scheduled for March 30, April 6, and April 25. All municipality officers are encouraged to register to attend a training class which will be filled on a first-come, first-served basis.

CLAIMS REPORT – NIP Group - C. Cyriax

- **Key Performance Indicators** Conrad Cyriax provided the Commissioners with the Claims Report. Key performance indicators of Claims Department activity were fully discussed including the number of new claims received and the sum of claims closed during the preceding month. Frequency trends affecting the Fund were discussed as well as other critical measurements of Claims Department activity such as closing ratio and recoveries.
- Opioid Litigation against Pharmaceutical Manufacturers and Distributors Conrad also reported on a request to join a class action lawsuit seeking damages against pharmaceutical drug companies based on their manufacture of opioid drugs. Following an investigation it was determined that the Fund's payout of Class II scheduled drugs was not sufficiently significant to warrant participation in the action as a class member.
