REPORTS

EXECUTIVE DIRECTOR'S REPORT - NIP Group - J. Hall

- **GSMJIF Actuarial Report Status** Mr. Hall reported that the mid-year reserve study is in draft form and is under review by the Administrator's office.
- Fast Track Report Mr. Hall reported that the Fast Track Reports for June through present will be finalized and distributed once the reserve study is complete.
- **GSMJIF Executive Committee meeting for 2019 RFP (Request for Proposal) posting** The Executive Committee will be meeting after this meeting to discuss the 2019 RFPs. RFPs will be posted Oct. 1, with a return date of Oct. 26.

TREASURER'S REPORT - P. DeBlasio

 Mr. DeBlasio reported that monthly financial report and cash management account has been reviewed. He advised that the Fund has met all outstanding obligations and its financial position is secure. There were no questions.

- Loss Runs As we explore opportunities for our program with interested excess markets, it is imperative that we receive 10-year loss runs for all lines. If you have not already submitted, please do so ASAP.
- **Applications** Signed and dated apps are required for all lines, please submit if you have not done so already.
- UST & Site Coverage These are separate placements that require signed and dated applications as well updated schedules and tests (depending on coverage). Please submit these to avoid any lapse in coverages.

SAFETY DIRECTOR – PMA Group (K. Child) and NIP Group (A. Ven Graitis)

• GSMJIF Safety Meeting Recap:

- Wellness The CPR/AED challenge will be the next GSMJIF wellness challenge. It will start on 10/1/18 and end on 12/31/18. The American Heart Association (AHA) Friends and Family Program is being supported and training is for employees who DO NOT need to be certified for work. Prizes will be given out to member municipalities for the highest employee participation and also randomly to employee participants. Participation will count towards the PEJIF Wellness Incentive Program requirements.
- Artificial Turf vs. Grass Artificial turf has become increasingly popular in communities across the country. As more grass fields are converted to synthetic turf a debate is brewing about the possible health risks and the advantages and disadvantages of artificial turf. Advantages of artificial turf fields include: lower maintenance costs, pesticide free, increased playability, fewer injuries (except ankles), and saves water. Disadvantages of turf fields include: heat hazard, bacterial breeding ground, increased MRSA risks, toxic run off, adverse effect on asthmatics, and health hazards from infill. A bulletin will be distributed to all members.
- O Presentation: Hillmann Consulting, LLC Underground Storage Tanks Chris Hirschmann, Mold Jill Asch. Mr. Hirschmann discussed the differences between unregulated and regulated Underground Storage Tanks (UST) and Aboveground Storage Tanks (AST), registration with the New Jersey Department of Environmental Protection (NJDEP), and spill prevention mechanisms such as leak detection alarms and secondary containment. The need to perform spill & remediation of leaking tank and Spill Prevention Control and Countermeasure Plan (Federal) / Discharge Prevention Containment was discussed. Ms. Asch explained what mold is, where it is found, what causes it to grow, and how it can affect the health of exposed individuals. Ms. Asch explained that no federal



standards or recommendations, (e.g., OSHA, NIOSH, EPA) for airborne concentrations of mold or mold spores exist. Individuals at highest risk and symptoms of exposure were discussed. Steps to take to resolve issues were outlined.

- Leaf Collection Safety/Work zone Safety The hazards of leaf collection, and accompanying work zones, was discussed. FACE Investigation Reports were reviewed including fatalities from a municipal road worker being run over by a leaf vacuuming truck and an employee falling off the trailer hitch of a leaf vacuum truck.
- O Police Best Practices Seminar 9/19/18 Recap Hosted by the Union County Police Chiefs Association, the GSMJIF and PEJIF, over 140 attendees representing over 40 organizations attended the seminar held at the Hamilton Stage at Union County Performing Arts Center, in Rahway NJ. Scenario-based discussion of lessons learned in the field presented by Chief Jonathan Parham, Union County Undersheriff and John More Esq. President Response Law, provided a combined legal and operational template on how to reduce and respond to risk created within the law enforcement workplace environment. James Renner- Director of Claims, NIP and John Sarno Esq. President Employers Association of New Jersey (EANJ) also participated on the panel counsel.
- o **Round Table Updates -** The Snow Plow Rodeo will again be held for municipal members. Risk control is looking to host the rodeos in three various locations across the state to accommodate members in certain geographic locations. In addition, a DPW roundtable and Fire roundtable will be scheduled in November.

CLAIMS REPORT - NIP Group - C. Cyriax, Robert Persico and James Renner

- **Key Performance Indicators** Bob Persico provided an update for Claims Key Performance Indicators (KPI's) for the months of July and August 2018.
- Bob Persico also presented three workers compensation cases for settlement authority, all three were approved for settlement.
- Upcoming Claims Seminar on October 3rd James Renner Jim Renner announced that the
 next town member claims seminar will be held on October 3rd in the NIP Auditorium in
 Woodbridge.
