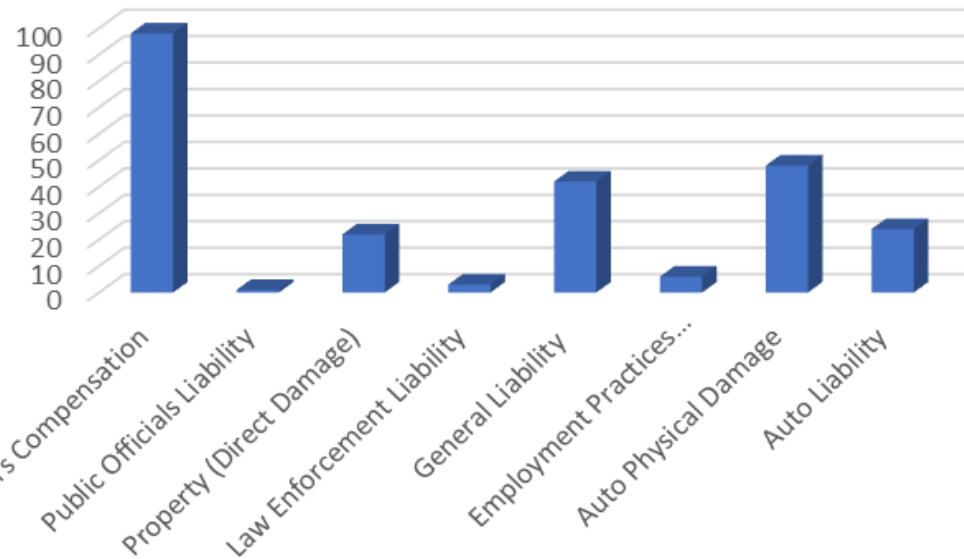

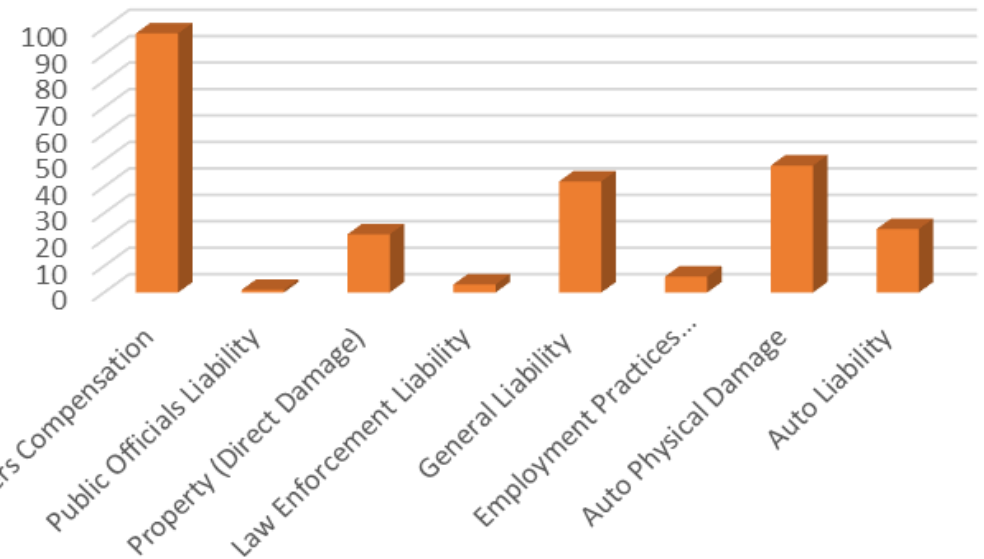

New Claim Count Jan. 2019



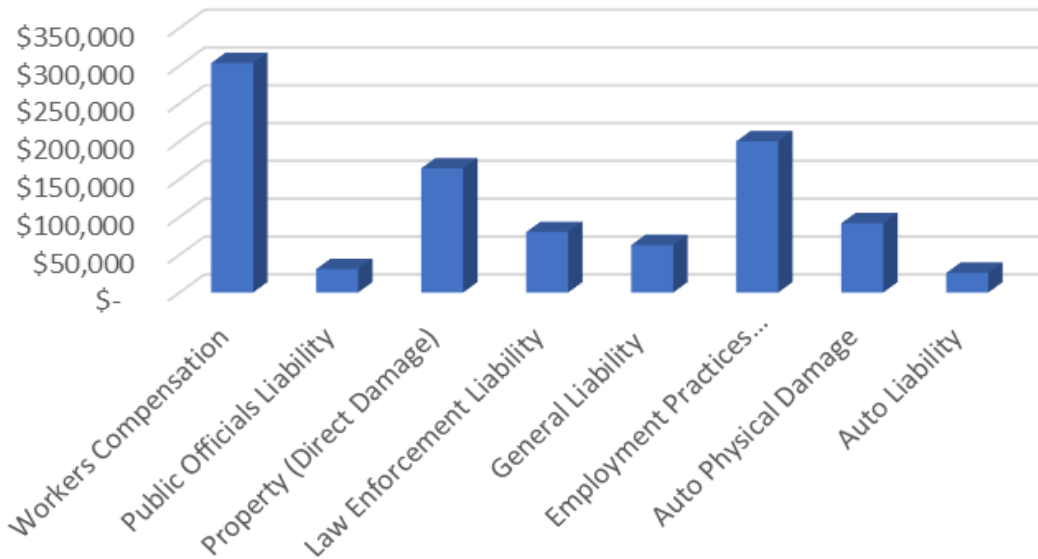
Hist. New Claim Count 2019 YTD



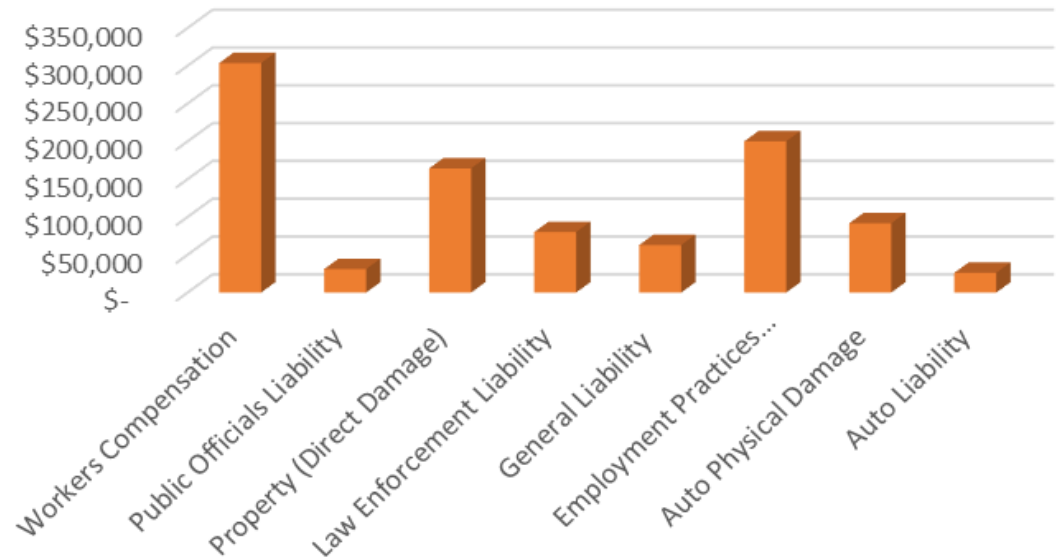

Severity of New Claims Jan. 2019



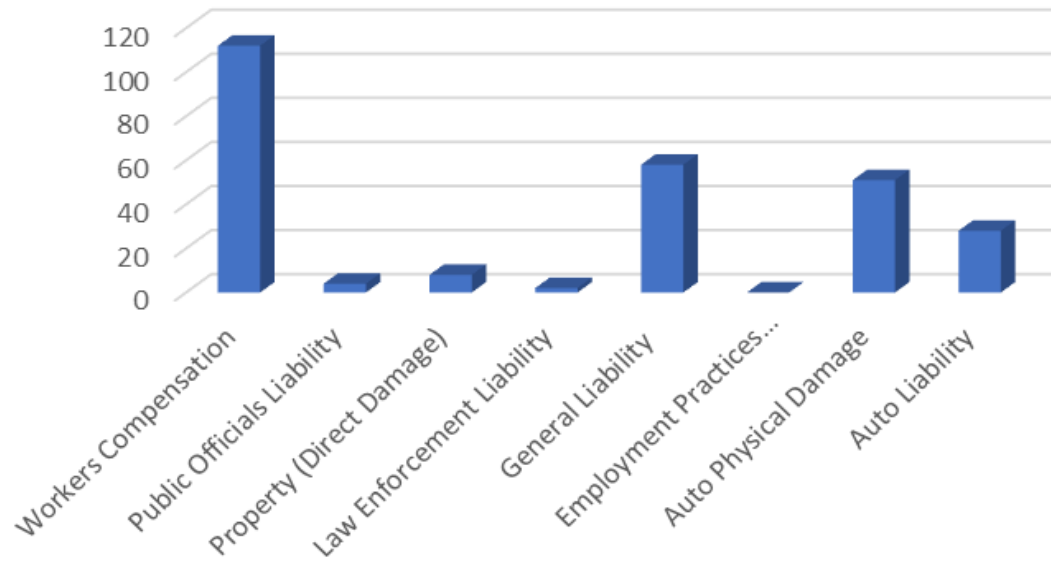
Severity of New Claims 2019 YTD



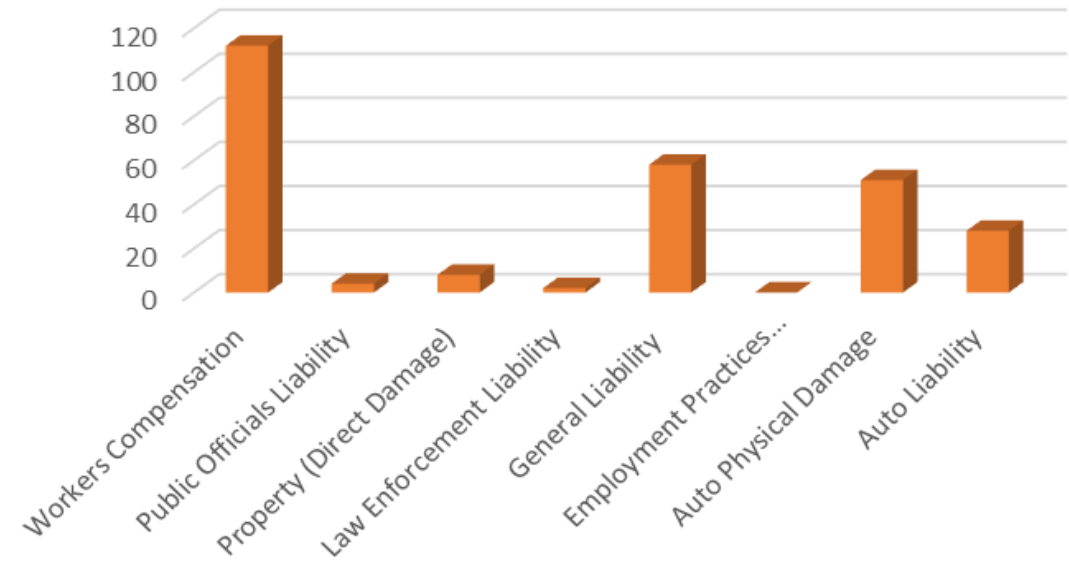

Closed Claim Count Jan. 2019



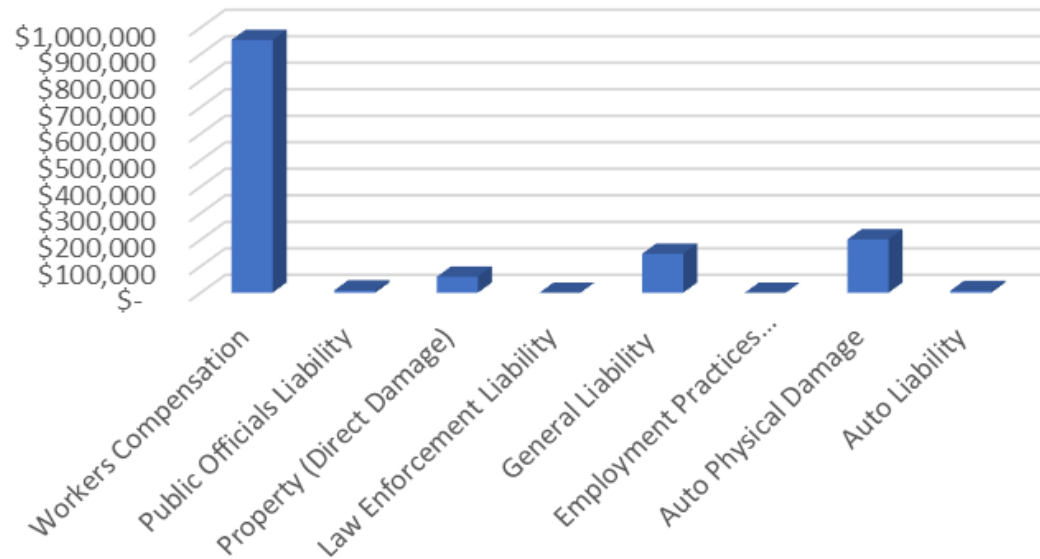
Hist. Closed Claim Count Jan. 2019



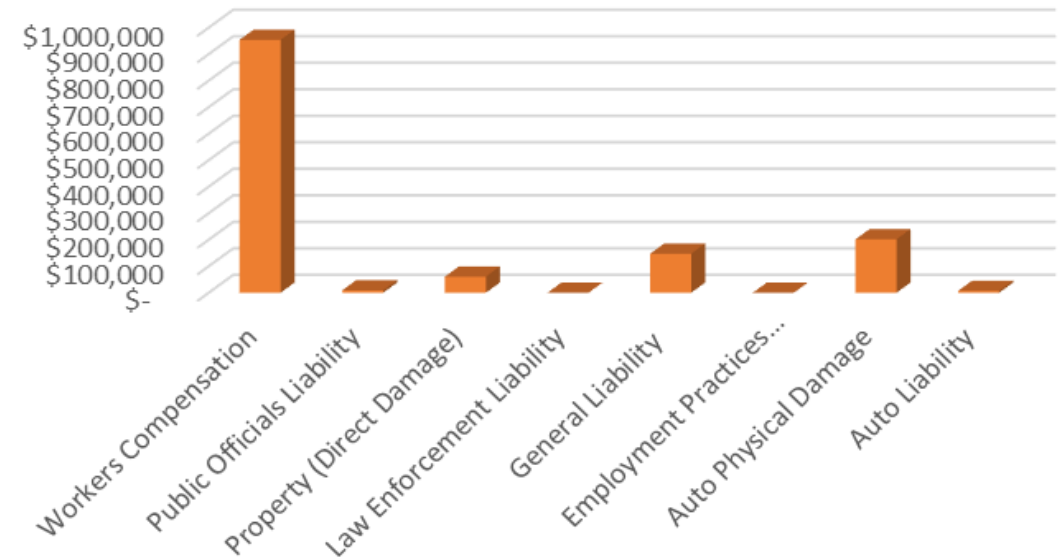

Severity of Closed Claims Jan. 2019

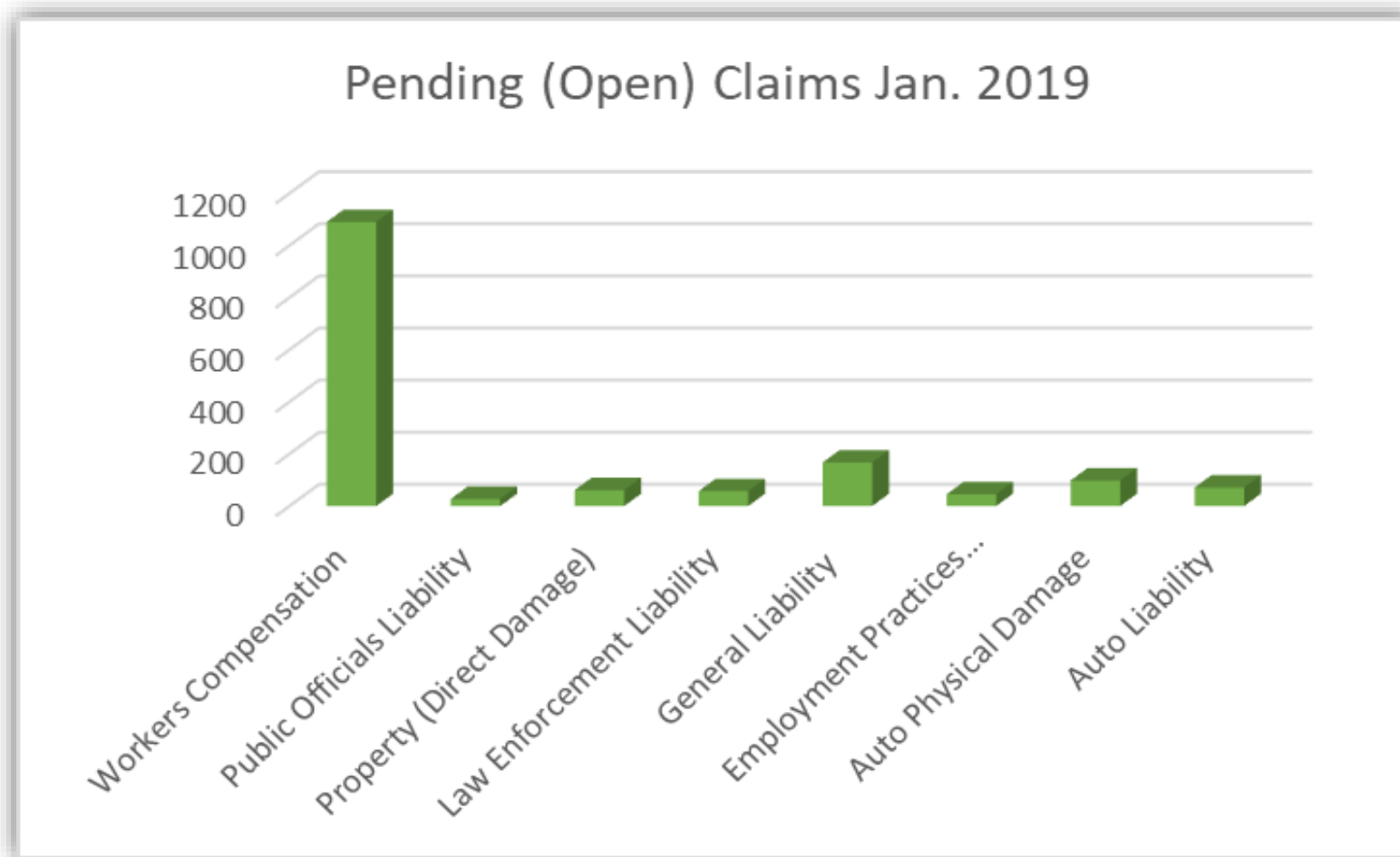


Severity of Closed Claims 2019 YTD
