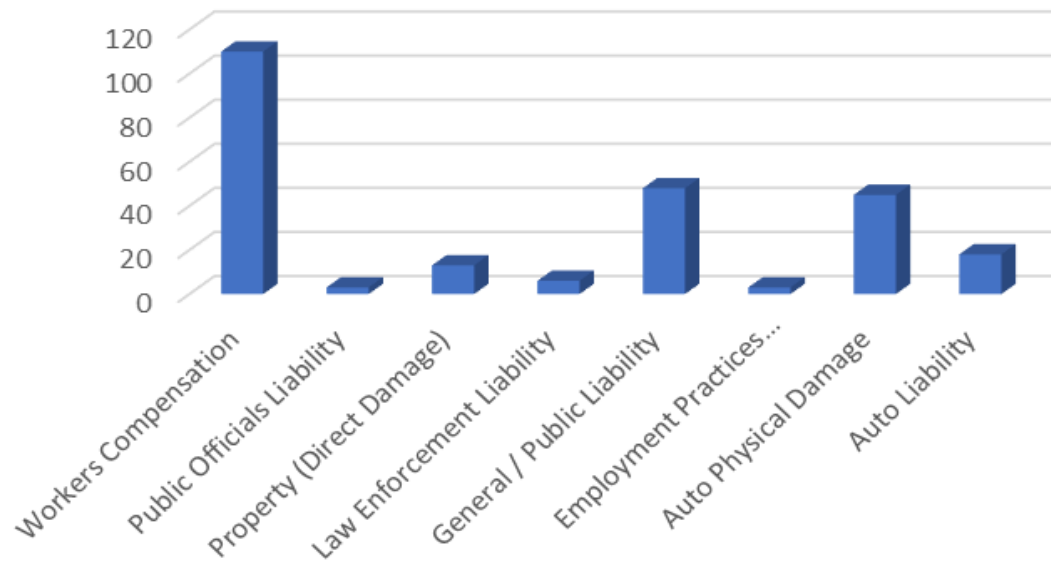

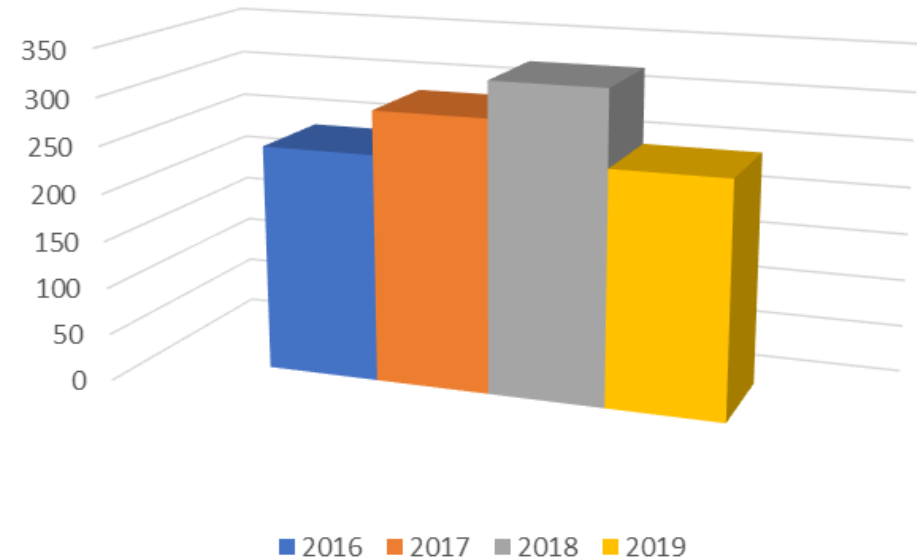

New Claim Count May 2019

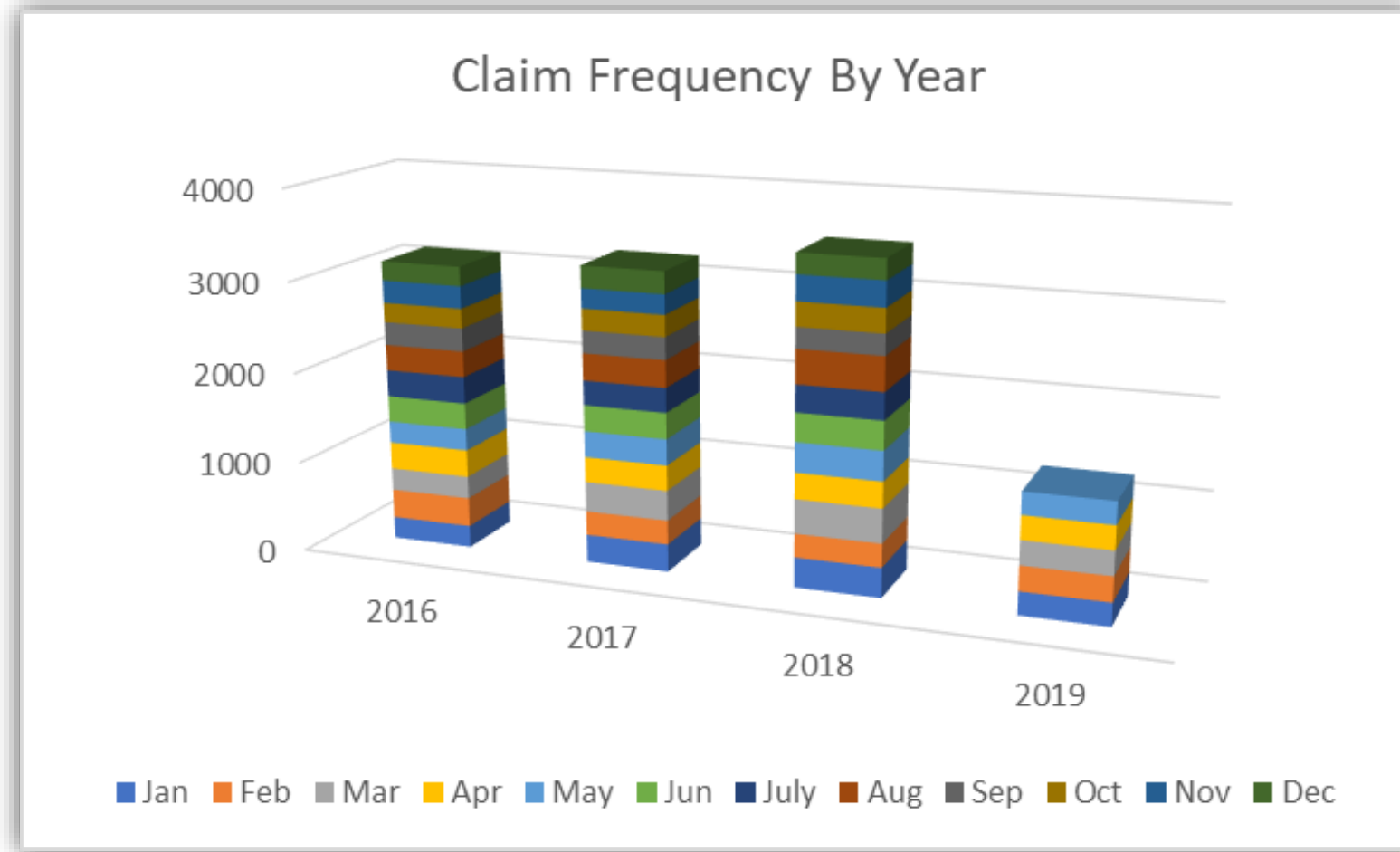


May New Claims by Year



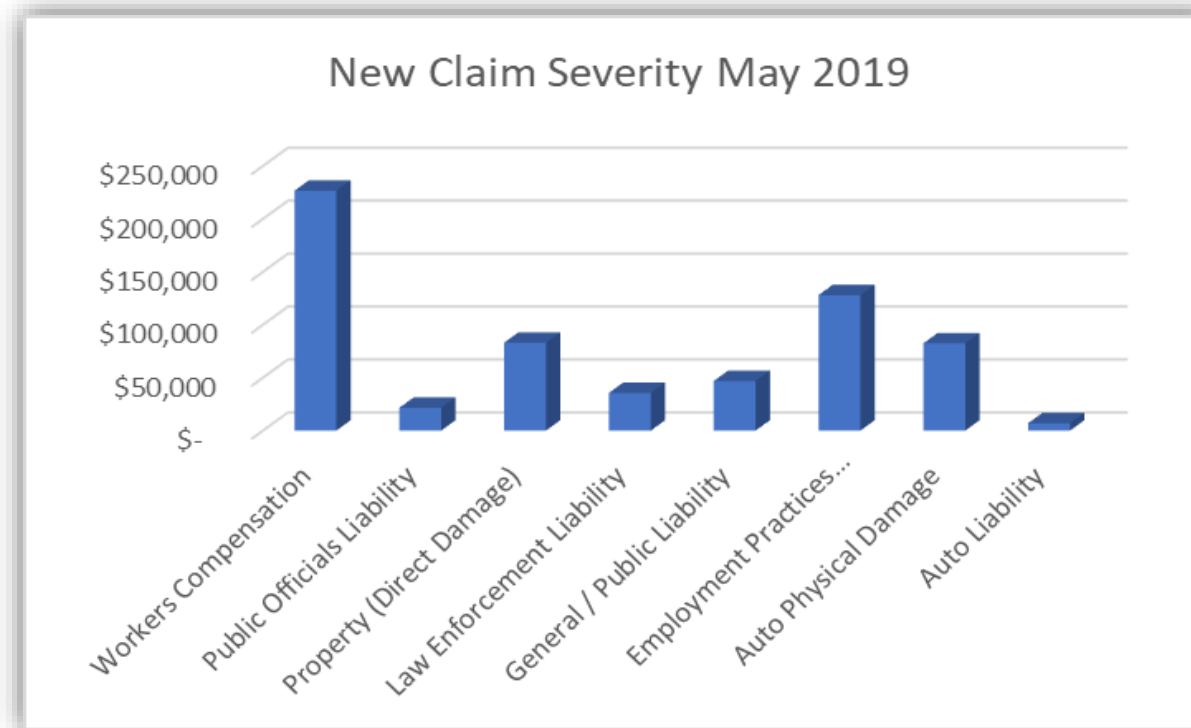

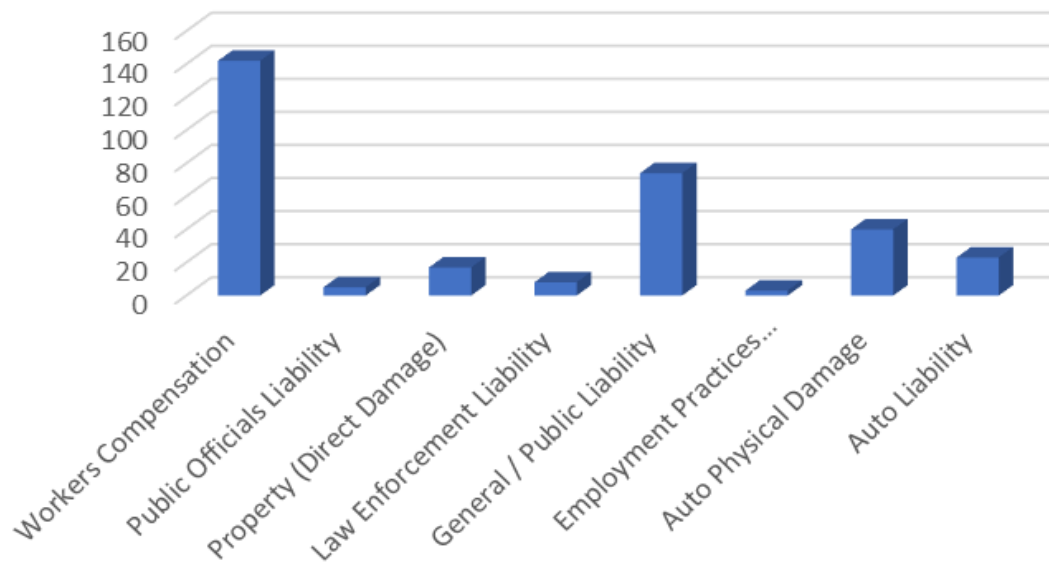
May 2019 – New Claim Severity



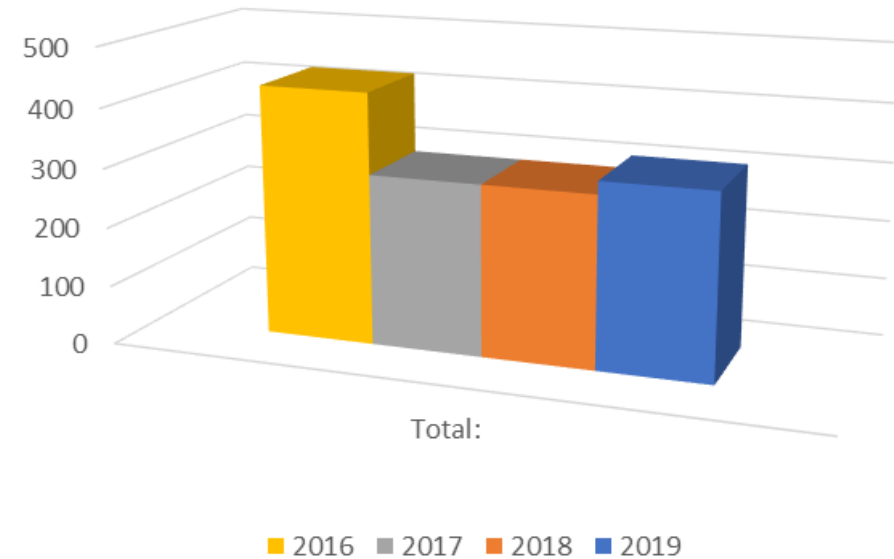

Closed Claim Count May. 2019



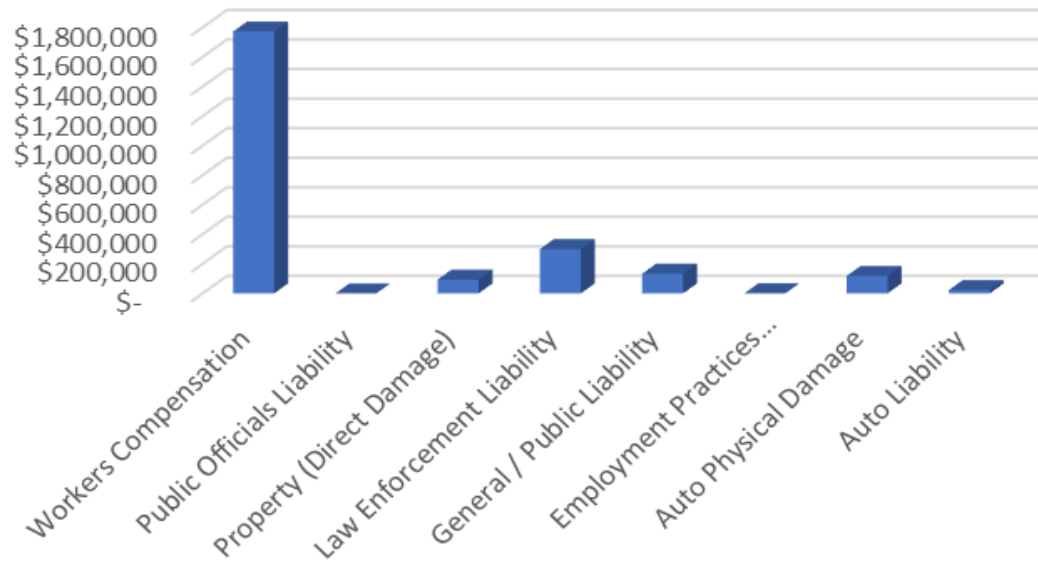
May Closed Claims by Year



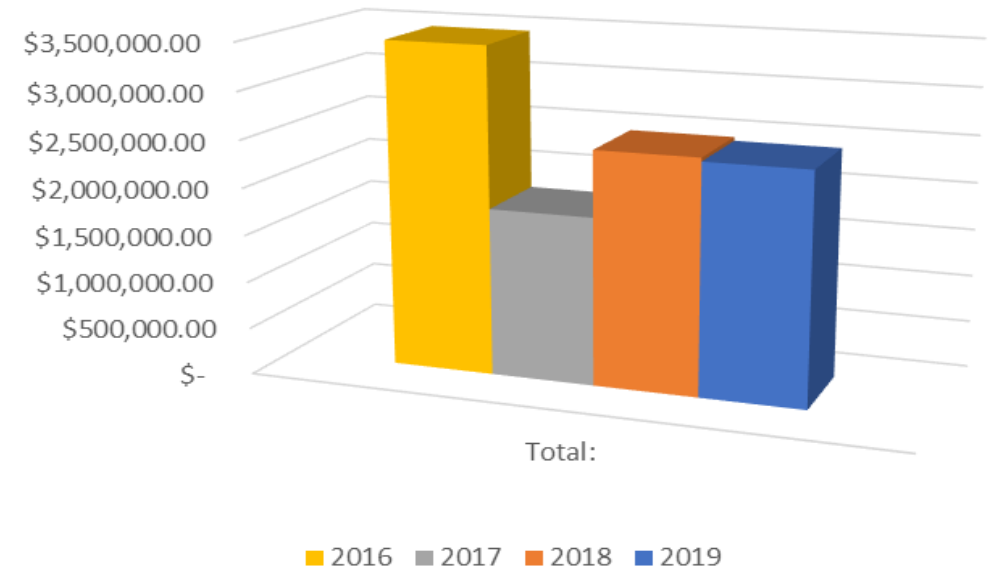

Severity of Closed Claims May 2019

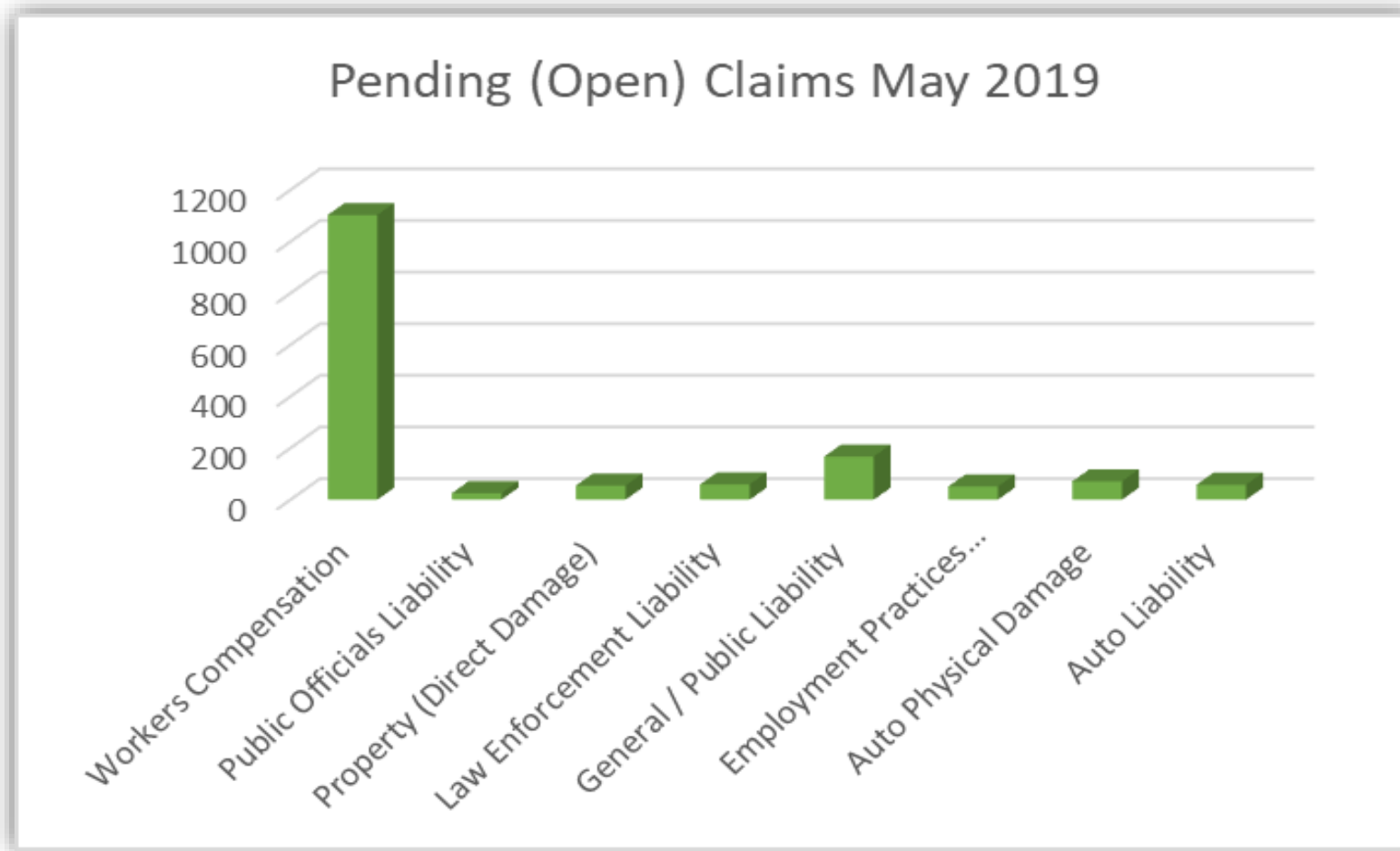


May Closed Incurred Amounts by Year



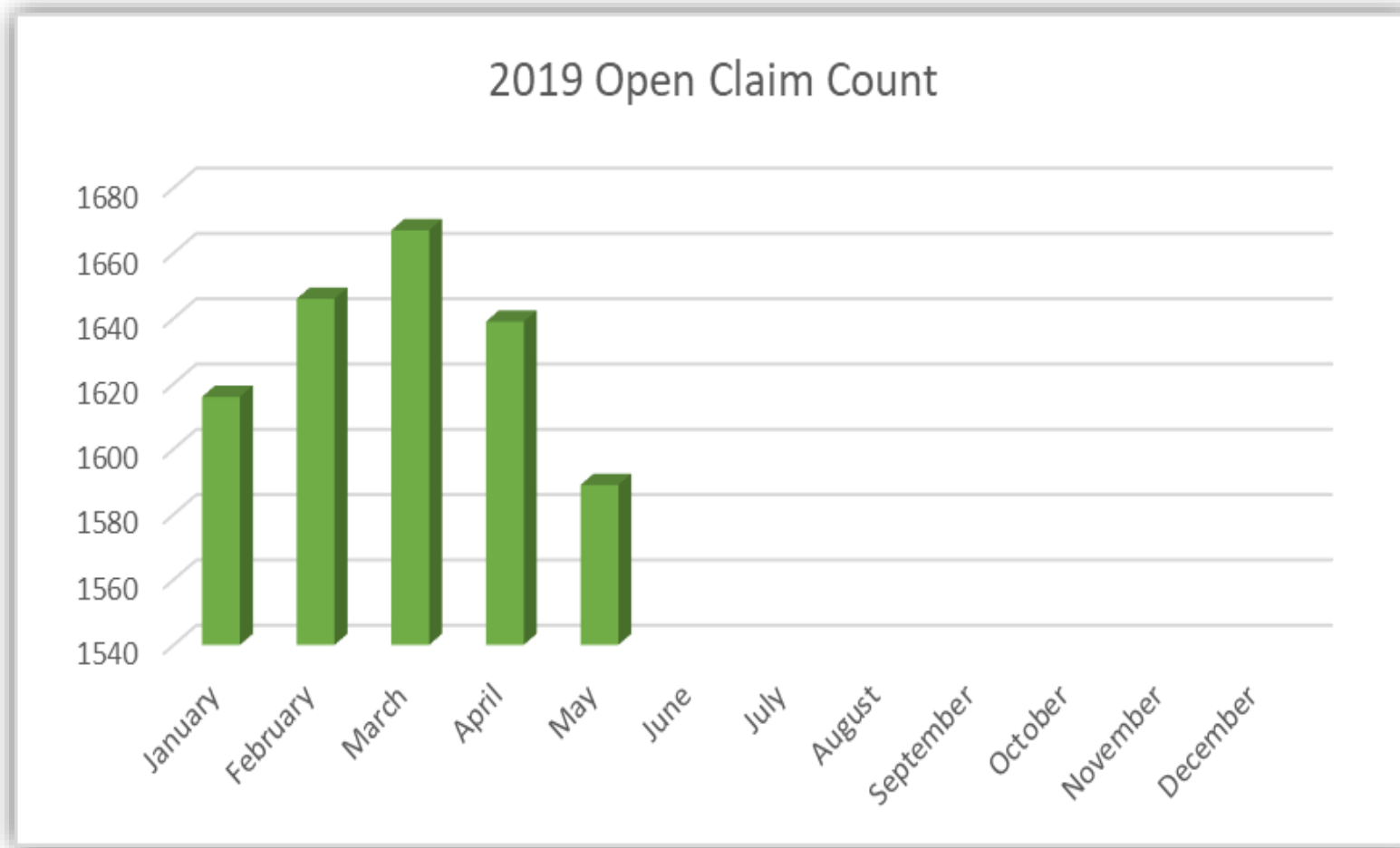
