EXECUTIVE DIRECTOR'S REPORT – NIP Group – J. Hall

- **GSMJIF Actuary Report Update** Mr. Hall discussed the year-end actuarial report. He noted an increase in frequency and severity of Auto claims, focused on distracted driving within the Police departments. Mr. Hall also noted the impact of crossing guard claims, permanency schedule increases and an again workforce on Workers' Compensation performance.
- **Fast Track Report** Mr. Hall presented the Fast Track Reports for December 2018, January and February 2019.
- **EPL Committee** The Fund is seeking Commissioners to serve on the EPL Committee. Any interested Commissioners should contact Mr. Hall. The Committee will be meeting immediately following next month's Commissioner meeting.

- **RFQ for Property Remediation and Restoration Services** The Fund is publishing a Request for Qualifications for its Property Remediation and Restoration Services Panel. The RFQ will be in the papers next week and the RFQ will close April 30.

TREASURER'S REPORT – P. DeBlasio - Mr. DeBlasio reported that monthly financial report and cash management account has been reviewed. He advised that the Fund has met all outstanding obligations and its financial position is secure. There were no questions.

SAFETY REPORT – PMA Group (K. Child) and NIP Group (A. Ven Graitis)

GSMJIF Safety Meeting Recap:

- **SPEAKER** Matthew Bickerton, MS, Entomologist from the Bergen County Department of Health Services, presented on Ticks and tick-Borne Diseases. Members were educated on the different types of ticks in New Jersey, the habitat and behavior of ticks, the hazards associated with ticks and their bites, how to avoid them, what to look for if bitten, and how to remove a feeding tick. Risk Control will incorporate some the advice provided in a bulletin to be distributed to further educate municipal employees.
- Wellness update
 - a) CPR/AED 2 -Over 530 employees were trained in CPR/AED, from over 17 municipalities between the PEJIF and GSMJIF. Lawrence Township ended up in third place with 51 employees trained, the Borough of Fair haven came in second place and trained 16 and Cinnaminson Township came in first place by training 44 employees. Awards were based on percent of employees trained from the overall employee pool. \$1,300 of prizes were award to the top three municipalities and randomly to employees who were trained.
 - b) Walk to Win 3 challenge will start April 22 and end June 7. Each municipality can be awarded prizes for teams that participate if certain requirements are met. The goal is for employees to track their steps and report to the municipality. 10,000 steps per day is the target for all employees. Best team names will be voted upon for prizes.
- When Words Fail -Verbal de-escalation and physical restraint training for police officers will be provided on April 23rd at the North Brunswick Middle School. Seats will be filled on



a first come, first serve request/registration process. An additional training will be scheduled in the upcoming weeks.
