- Mid-Year Actuarial Analysis and Fast Track Status The Administrator's office has submitted updated loss data as of June 30, 2020 to the Fund Actuaries. Once the Actuaries have reconciled the data, we anticipate receipt of the first draft of the Reserve Study in four weeks. We will update the Fast Track Reports for June 2020 and following once the Reserve Study has been finalized.
- DCA Financial Disclosures DCA has extended the deadline for filing the annual Financial Disclosure to July 31
- o **Treasurer's Report** All Bills have been paid and our cash balance is secure.
- Renewal Cycle for 2021 All of the applications and forms for 2021 are on-line at <a href="https://members.gsmjif.com">https://members.gsmjif.com</a>. Loss Runs were due in Excel format no later than July 17, 2020.



- Exposure Schedules and Applications must be submitted online no later than August 7, 2020. Members are asked to work closely with their risk managers to meet these deadlines
- Reopening Outdoor Playgrounds The Fund's Risk Control Team sent out a bulletin on July 6, 2020 to all Commissioners, Public Works Department Heads, and Risk and Safety Managers. Executive Order # 157 permits public playgrounds, outdoor amusement parks, and outdoor water parks to reopen beginning on Thursday, July 2, 2020.
- O Heat Related Illnesses The Fund's Risk Control Team sent out a bulletin on July 10, 2020 to all Commissioners and Department Heads. Governor Phil Murphy signed Executive Order No. 163 on Wednesday, July 10th, which requires individuals to wear face coverings in outdoor public spaces when it is not practicable to socially distance and keep a six-foot distance from others, excluding immediate family members, caretakers, household members, or romantic partners. Face coverings and PPE significantly increase risk the risk of heat related illnesses.
- o **Know your Risk During COVID-19** The Fund's Risk Control Team shared an infographic from the Texas Medical Association.
- Modified & Transitional Duty: What Police & Fire Officials Need to Know The Fund 's Risk Control Team sent out a bulletin on July 10, 2020 to all Commissioners and Department Heads with a reminder on the value of Modified Duty.
- o **Midterm Training Review** The Fund's Risk Control Team presented Training Utilization by Member statistics for 2019 through June 30, 2020.
- Webinar "Risk Reduction Practices for Protests & Civil Unrest." The webinar was held on July 21st, from 2:00PM-3:00PM (EDT)
- o Claims Report The Fund Administrator presented the claims report for June 2020.
- Update on OPRA Requests The Administrator reminded the Members to provide any OPRA requests involving Law Enforcement Liability claims to the Administrator's office as soon as possible so the Fund can adequately respond to such requests.
