## • EXECUTIVE DIRECTOR'S REPORT (Jonathan Hall)

- Status Report Mid-Year Actuarial Study The work on the Mid-Year Actuarial Reserve Study has been delayed due to the untimely passing of the Fund Actuary, Mujtaba Datoo. We have received the first draft reserve study and are reviewing it for finalization in upcoming weeks.
- Status Report Fast Track Per our normal practice, updated Fast Track Reports will be distributed once the Mid-Year Actuarial Reserve Study has been finalized.
- **Treasury Report** Mr. Hall shared the Treasurer's Report. All Bills have been paid and our cash balance is secure.

## • UNDERWRITING REPORT (Robert Smith)

- **2022 Renewal Update** The 2022 renewal process has begun, and both deadlines have now passed. We are asking all risk managers review and update of current underwriting data with their client municipalities at this time. Risk managers must update and return all outstanding loss runs to the Administrator's office by September 10th, 2021. All schedules must be updated, signed and returned to the Administrator's office by September 10th, 2021.
- Quasi-Municipal Entities Risk managers and municipalities are to identify any Quasi Municipal Entities and any exposures (property, vehicles, equipment etc.) related to said entities.
- **Exposure Schedules** In light of the recent claim activity due to the storms, we are asking all members and risk managers to take some extra time to ensure the schedules we have on file for locations and auto are up to date. We ask that all new locations please be added in a timely matter to ensure all proper coverages are in place. Additionally, we ask that all vehicles are added when acquired and any vehicles no longer covered be removed from the schedules.
- Website Re-design We are currently working with our IT vendor on developing an updated member portal. We have started early testing and are impressed with the new look and functionality of the site. At this time, we are continuing testing and will be open to have some risk managers try out the site for feedback.

## • **RISK CONTROL REPORT (Anthony Ven Graitis)**

- National Preparedness Month and Seminar September is National Preparedness Month, and the recent storms impacting New Jersey certainly reinforce the need to be prepared for all types of weather. The 20th anniversary of the 911 attacks also reminds us that unfortunately, weather is not the only risk we need to consider as we work our way through the ongoing COVID Pandemic. This seminar will review some of the lessons learned from the flooding, severe winds, and power outages caused by Henri and Ida. We will review best practices to mitigate the impacts of these incidents and discuss how your organization can be better prepared for future events.
- **Cyber Training Update** Mr. Ven Graitis reported that 3,361 GSMJIF-insured employees have completed Cyber Awareness training. As a reminder, all municipal employees must complete Cyber Awareness training by May 1, 2022 in order for the member to be considered for Cyber coverage effective July 1, 2022.
- Employment Practices Resources during COVID Employers Association of New Jersey: Sample handbook, Training for employees, and Hotline for questions (including regarding vaccine mandates!); PMA Companies: Training Resources, and Supervisor Training. Vault-Learning Management System (LMS): Bulletins, policies and procedures, Online Training, and HR Library.



- Workers Compensation Transitional Duty Lost time claims account for over 90% of workers' compensation costs per year. "Transitional Duty" jobs are proven to return employees back to work sooner. The consistent implementation of a Transitional Duty policy will reduce costs over the long term. Contact your claims representative or risk control consultant for assistance.
- **Boiler Inspections** Jurisdictional Boiler inspections are required annually by the State of New Jersey. Inspections can be performed by either State Inspectors (at member expense) or through the GSMJIF insurance company: APIP- Hartford Steam & Boiler (HSB)
