- **2024 Insurance Placement Update** BGIA continues to work tirelessly to get our members the most cost effective and complete coverage. At this point all major lines are bound and we are in negotiations for the ancillary lines.
- **2024 Renewal** The deadline for applications is well past due. Any applications for ancillary lines currently missing will be seen as a formal request to non-renew that line. Please don't allow for a gap in coverage to occur and get all the applications in as soon as possible.
- **Member Portal** The member portal is currently closed as we finalize the schedules for our excess placement. Should you need to add, delete or edit anything in the portal, please reach out to underwriting and we will be happy to assist you.
- **Prospects** We currently are exploring all possibilities for prospects. At this time, we are exploring 5 municipalities who fit our guidelines. They are in various stages of underwriting, and we will report back next month with any updates.

# **RISK CONTROL REPORT (Anthony Ven Graitis)**

#### Safety Recap:

- Holiday Safety Driving Safety / Holiday Parties consider the following: Limit drinking. Provide rides for intoxicated individuals. Stress, consider the following: For many the holidays is a tough time of the year. Counseling is offered for law enforcement via Cop to Cop. UBHC can provide support for our members (if you sign up at a discounted rate).
- **OSHA top violations of 2023** During street repairs and leaf pick up- use proper signage and lights, provide blockades where needed as well. Working from Heights (hanging decorations / gutter cleaning). Inspect ladder before use. Tie off the ladder and use a ground spotter Snow & Ice: Be sure to track where and when you salt and plow. This information may be needed for a title 59 defense. Be sure staff wears proper footwear. Protecting



Property during cold weather: Insulate pipes. Don't drop thermostat temperature so low that pipes freeze. Limit candle use.
