- **Risk Manager Agreements** The Administrator's office requests that all Risk Managers please return fully executed copies of your Risk Management Consultant Agreements. As a reminder, service providers cannot receive payment from the Fund without a signed agreement authorizing the expense.
- **2024 Budget** Mr. Hall presented the updated 2024 Draft Budget. There were no questions.

- Outstanding Items All outstanding items are due ASAP. Missing items will result in a lapse in coverage.
- **Insurance Placement Update** All major lines have been bound, we are working on closing out all the ancillary lines now as well. BGIA will report on the renewal at the February meeting.
- **Prospects** We reviewed numerous prospects, and pursued several opportunities but at this time, no new members will be joining the fund.

### **RISK CONTROL REPORT (Anthony Ven Graitis)**

#### **Safety Recap:**

- Snowplow Rodeo Thank you to Township of Union for hosting the 6th Annual Snowplow Rodeo. A great event was held with over 40 professional drivers testing their skills, steering through an obstacle course of left and right turns, maneuvering around parked cars and moving through a serpentine series of cones, while timed for speed, safe driving and judged for effectively pushing the snow (markers must be moved) while avoiding parked cars and other obstacles. A CDL and non-CDL driver category was used based on the vehicles driven. Winners in the CDL Category were:1st Place, Gary Gordon of Monroe Township, 2nd Place, Richard Reinitz of Monroe Township and 3rd Place, Ryan Mangan of Lawrence Township. Winners of the Non-CDL Category were:1st Place, Ibrahim Elbanna of Union Township, 2nd Place, Joe Reid of Monroe Township and 3rd Place, Paul Pawlowski of Monroe Township. Congratulations to all the drivers but especially these six who placed, as they truly demonstrated their professionalism and driving skills.
- Winter Weather driving with very limited snow events in the past two years, risk control is reminding all drivers to be mindful of possible inclement weather in the upcoming weeks. Online Defensive Driving-Reducing Weather Accidents, is available to any interested drivers. Drivers should consider watching the weather before driving, slow down in inclement weather, increase spacing 8 to 10 sec, check tires, check wipers and fluid, clean exterior of snow/ice, steer in the direction of a skid, don't overcorrect, and accelerate and decelerate slowly.
- Unregulated Private Police Training The Office of the State Comptroller (OSC) issued a report on 12/6/23 on unregulated private police training. Post-academy police training in NJ is not regulated. A six-day conference in October 2021 was referenced, where the report states that unconstitutional policing tactics for motor vehicle stops were promoted, training glorified violence, and training included over100 discriminatory and harassing remarks. Risk Control asks all members to consider retraining participants of this training, and to use only well-known trainers and curriculum promoted by Risk Control.
- Sexual Abuse and Molestation Best Practices Critical allegations were recently made against a GSMJIF Member. Risk control is asking every member to review hiring and training policies and procedures. Any employees working with the vulnerable, elderly or youth must have comprehensive background checks made. Risk Control has training and resources available.
